
Waitangi Tribunal claims update

- Crown closing submissions on Landlocked land and Generic on Native Land Court/Crown breaches were held at Rātā /Wellington
 - The Crown made a number of important concessions
 - Landlocked land was noted as "akin to land loss"
- Final Crown Closing Submissions Moawhango 9-11 June
 - We ask as many of our whānau to attend, especially on the 9th June
- Then Claimant response to Closing Submissions Kua Mutu!
- Hearings process concluded and Tribunal deliberate to write their report(s)
 - o Tribunal may release an early Landlocked Lands report this year

- Extensive work undertaken pre-mandate phase
- Draft Mandate strategy advertised **Dec 2017**. Submissions,
 Mandate Vote, More Submissions
- Final draft Deed of Mandate submitted to Te Arawhiti **Nov 2020**
- First meeting with the Crown held on **26 Feb 2021** with Andrew Little, Minister for Treaty Negotiations. Confidence in our mandate.
- Mandate confirmed 17 March 2021 by Ministers Little and Jackson

Negotiations Pātea Waitangi Claims Trust

Terms of Negotiation

- Sets the ground rules and objectives for negotiations
- Non-binding agreement between the two parties as we have only agreed to negotiate
- The first agreement signed with the Crown (since the Treaty of Waitangi)
- Each Rūnanga will be consulted on the draft terms of negotiation
- May take 5-6 months to complete this stage, or earlier if possible

Implementation of the Deed of Mandate and Mandate Maintenance

- Negotiating Team appointment process being developed
- Recruitment of Negotiators guided by:
 - $_{\circ}$ Geographic spread
 - Fair representation of iwi Rūnanga
 - Skills and experience
 - Experience in negotiations
- Other Accountability processes in the Deed of Mandate
- MPWCT have also committed to developing particular Redress
 Strategies to guide negotiations

Communication Strategy

- Communication with Claimants
- Communication with Registered Members of MPWCT
- Communication with Rūnanga and Rūnanga delegates
- Information Hui at key junctures
- Marae Engagement strategy
- Opportunities for Engagement with Heritage Trust continues, including an invitation sent by MPWCT this week to meet to discuss implementation of the Deed of Mandate
