

#### TO BE ELIGIBLE TO STAND FOR ELECTION AS AN IWI RŪNANGA HAPŪ DELEGATE REPRESENTING TE RŪNANGA O NGĀTI HAUITI

### Nominations received after this date and time will <u>not</u> be accepted.

- 2 Every candidate must be nominated by one (1) person who is 18 years or older and registered on the Mökai Pātea Members Register as being eligible to vote in the iwi rūnanga hapū for which the candidate is seeking election.
- 3 A candidate may not nominate themself for office.
- 4 Each nomination should be accompanied with a candidate profile statement (attached), and a current passport-size photo. Candidates should be aware that this information will be made publicly available for voting purposes.

Photos should preferably be in colour. If supplied in electronic format, it should be provided by email in a jpg format. Hardcopy photos will be accepted, and will be scanned at 300dpi by the Returning Officer. (NB: hardcopies of photos will not be returned to the candidate).

- 5 If only two (2) valid nominations are received for a particular Hapū of Te Rūnanga o Ngāti Hauiti Iwi, then those two (2) candidates will be declared elected unopposed. If three (3) or more valid nominations are received for a particular Hapū of Te Rūnanga o Ngāti Hauiti Iwi, an election will be conducted by a postal ballot of persons registered to vote for that Hapū.
- 6 The candidate must sign the form of nomination to show their consent to the nomination. Failure to do so will make the nomination invalid.
- 7 The candidate must <u>not</u> be ineligible to stand for election for any of the reasons outlined in clause 6, schedule 1 of the Mōkai Pātea Waitangi Claims Trust Deed of Trust (and as outlined below):

#### Mōkai Pātea Waitangi Claims Trust Deed of Trust Schedule 1: Election and Removal of Rūnanga Delegates Clause 6: Termination of office

- 6.1 A Rūnanga Delegate will cease to hold their position if he or she:
  - a. is censured under this Deed for acting in a manner that brings or is likely to bring into disrepute the Mōkai Pātea Waitangi Claims Trust, or the lwi Rūnanga for which the Rūnanga Delegate has been elected;
  - retires from office by giving written notice to the lwi Rūnanga;
  - c. refuses to act;
  - d. is absent without leave from 3 consecutive ordinary meetings of the Iwi Rūnanga, without reasonable excuse;
  - e. becomes physically or mentally incapacitated to the extent that in the opinion of the other Rūnanga Delegates, expressed in a resolution, he or she is unable to perform the duties of a Rūnanga Delegate;
  - f. ceases to fulfil the eligibility requirements for election;
  - g. becomes bankrupt;
  - h. completes his or her term without being re-appointed; or
  - i. dies.

## Lodgement of Nomination Forms

- Nomination forms must be in the hands of the Returning Officer, at the offices of electionservices.co.nz no later than 5pm, Thursday, September 14th 2023.
- Nominations received after the closing deadline are invalid and will not be processed.
- To ensure that completed nomination papers are received and processed in time they should be scanned and emailed to info@electionservices.co.nz.

- Once lodged, nomination papers are checked by the Returning Officer to ensure that the candidate and nominators are registered adult member of one of the rūnanga.
- Please do not leave lodging your nomination to the last minute. Should a nomination form contain errors or cannot be read, it could leave the candidate with insufficient time to correct the situation, and the candidate will be ineligible to stand for election.
- Candidates will receive an email from the Returning Officer acknowledging that their nomination form has been received and is being checked to determine validity. A further email will be received once this has occurred to advise of the outcome and if any further action is required. Any further information requested must be received before nominations close at 5.00pm on Thursday 14 September 2023.

### MŌKAI PĀTEA IWI RŪNANGA HAPŪ DELEGATE Role Description

These are the key operating principles, responsibilities and competencies required of iwi rūnanga delegates representing the four iwi and affiliated hapū within the Mōkai Pātea confederate.

### **BROAD PURPOSE OF THE IWI RŪNANGA**

- 1. Protect and enhance the mana and rangatiratanga of the respective iwi and hapū, while exercising kaitiakitanga over identified taonga tuku iho
- 2. Uphold the kawa, tikanga, whakapapa, mātauranga and reo of the iwi
- 3. Promote and advance the social, cultural, environmental and economic wellbeing of iwi, hapū and the people
- 4. Act as a central point of contact in dealings with the Crown, local authorities, other iwi, and external stakeholders
- 5. Represent iwi and hapū in respect of grievances laid against the Crown in relation to the Treaty of Waitangi.

#### PRINCIPLES

Iwi rūnanga delegates will be guided by the following values and principles:

- 1. Collective leadership
- 2. Ethical decision-making that is in the best interest of the iwi and its hapū
- 3. Open and transparent engagement and communications with iwi and hapū members
- Integrity and honesty delegates will do nothing that negatively impacts on the reputation or operations of the iwi.

#### RESPONSIBILITIES

#### Delegates are expected to:

- 1. **Develop** and provide oversight around the implementation of key initiatives that further the strategic goals and priorities of the iwi.
- 2. Advocate for the needs and priorities of the hapū they represent
- Represent the interests of all members of the iwi irrespective of their own direct whānau and hapū affiliations
- 4. Lead and/or support any topical issues as and when they arise.

## **Core Competencies**

### **CORE COMPETENCIES OF DELEGATES**

Iwi Delegates should demonstrate qualities and competencies in some or all the following:

- 1. 'Mōkai Pāteatanga' versed in taha Mokai Patea (Ngāti Tamakōpiri, Ngāi te Ohuake, Ngāti Hauiti, and Ngāti Whitikaupeka)
- 2. Demonstrated ability to develop and maintain effective working relationships with a wide ange of stakeholders including whānau, hapū, other iwi, Crown, local authorities, and external entities
- 3. Strong leadership skills
- 4. Sound judgment and political acumen to be able to navigate and lead in a political environment as well as handle contentious and/or sensitive issues
- 5. Proactively identifies and manages new risks and opportunities as they arise
- 6. A team player with the ability to lead and contribute to robust discussions on matters impacting on whānau, hapū and iwi
- 7. Effective written and oral communication skills.

#### TIME REQUIREMENTS

In general, each Rūnanga will meet at least once every quarter with additional time allocated for annual hui-a-iwi and separate Strategic Planning hui. You may also be assigned a portfolio or asked to represent the rūnanga on kaupapa outside of the above set meeting times.

The role is that of a volunteer. Each lwi Rūnanga will have its own policy and practices regarding expenses incurred by volunteers.

#### TERM OF OFFICE

4 LENGTH OF TERM FOR HAPŪ DELEGATE

All successful candidates, whether elected unopposed or through a formal vote, will be elected for this term length.



## Candidate Profile Statements

While this is optional, candidates are encouraged to provide a profile to promote their candidacy. There are strict word limitations and the Returning Officer has been advised to use the first **150 words** only.

- Must not exceed 150 words in total.
- Must be confined to information concerning the candidate, and the candidate's policies and intentions if elected;
- It's good idea to highlight your skills and experience, hapū and rūnanga affiliations
- The text (English or Māori) must be plain black and white text, and tohutō are permitted.
- Photos should be recent (i.e. less than one year old) photograph of the candidate only (i.e. not part of a group)
- Photos should preferably be in colour and supplied in an electronic format (phone photos are fine), but hard copy photos will be accepted and will be scanned at 300 dpi by the Returning Officer. (N.B. hard copies of photos will not be returned to candidates).
