
Waitangi Tribunal claims update

- > Hearing's process concluded October 2021
 - ➤ No decision yet on Gwavas/Kaweka
- > Tribunal write their report
 - >Tribunal had indicated an early release for a Landlocked Lands report in last stages of hearings.
 - No report has been released yet.
- > Sir Doug Kidd has formally resigned from Waitangi Tribunal Panels (May 2023).


